

## **DON H. LIU SCHOLARS PROGRAM**

### **2018 – 2019 APPLICATION**

#### **Background**

Founded in 2014 by two past presidents of the Asian American Bar Association of New York (AABANY), the Don H. Liu Scholars Program, Inc. seeks to identify, cultivate and inspire future Asian American leaders within the legal profession in order to address the single most important reality facing Asian American professionals today – the barrier to advancement.

Asian Americans remain grossly underrepresented in positions of influence, leadership and power within the legal profession. The number of Asian American partners in law firms and general counsel in our largest corporations do not reflect the diversity found in today's law schools or the ranks of junior associates at law firms. It is the mission of the Program to increase these numbers.

In 2019, the Selection Committee will choose up to three 1Ls who possess the greatest potential to both excel in the classroom and succeed at a top law firm or Fortune 500 corporation. The Program will also provide mentorship and assistance with career development, including identifying potential internships.

#### **Eligibility:**

To be eligible, the applicant must meet the following criteria:

- Be a U.S. citizen or permanent resident of Asian descent;
- Be enrolled full-time as a 1L in a law school in Connecticut, Delaware, Maryland, Massachusetts, New Jersey, New York, Pennsylvania or the District of Columbia and expected to graduate in 2021;
- Be eligible to participate in on-campus interviews or early interview week programs at the end of the first year;
- Be among the first in his or her immediate family to go to law school and whose parents do not possess a graduate or professional degree;
- Demonstrate exceptional academic accomplishments and leadership;
- Demonstrate financial need; and
- Intend to practice in the private sector in the New York City metropolitan area following graduation.

To apply to the Program, applicants must submit a completed Scholarship Application along with all supporting documents as detailed in the instructions.

#### **Deadline:**

The deadline to submit the Scholarship Application is **November 23, 2018.**

### **Information about Process and Dates**

- All applications are due by **11:59 PM (Eastern Standard Time), November 23, 2018.**
- All applications are considered the property of the Don H. Liu Scholars Program, Inc. and any materials submitted in support thereof will not be returned.
- All applicants who advance as finalists will be notified to submit additional materials (see Final Round materials under Application Instructions) and/or informed of dates for a possible interview no later than January 4, 2019.
- The 2019 Don H. Liu Scholars will be notified no later than February 15, 2019.
- No other notice will be provided to applicants unless deemed required by the Executive Committee.

### Application Instructions

All submissions for the Preliminary Round must be received on or before **11:59 PM (Eastern Standard Time), November 23, 2018** and only completed applications will be considered.

2. Preliminary Round- required application materials:

- a. A completed Application Form;
- b. Two essays addressing the topics below;
- c. Résumé;
- d. An official copy of applicant’s undergraduate transcript; and
- e. A signed Personal Certification Form.

3. Essay Topics:

- a. *The Don H. Liu Scholars Program seeks to identify and empower future Asian Pacific American (APA) leaders in the legal profession through a unique blend of financial support, legal internship and professional mentorship. The Scholars Program specifically targets disadvantaged APAs, particularly those who are among the first to attend professional or graduate school in their families. Using specific examples from your personal life, academic and extracurricular accomplishments, tell us why you are the best candidate to advance the mission of the Scholars Program.*  
(Approximately 500 words.)
- b. *Describe any personal challenges you’ve had to overcome before law school and why you would benefit from this program, or tell us anything else we should consider in reviewing your application.*  
(250 – 500 words.)

4. Final Round - the Executive Committee will select finalists based on materials submitted from the Preliminary Round. Finalists will be then be notify to submit the following:
  - a. Two letters of recommendation;
  - b. A statement from applicant's law school certifying enrollment as a full-time 1L;
  - c. A copy of applicant's official financial aid package from his or her law school;  
and
  - d. Two years of applicant's family's most recent tax returns (even if applicant has declared to be financially independent), and a statement (no more than a paragraph) describing your financial need (with any supporting documents).
